2. The NVR shall be capable of storing up to 32 TB of data from [16 IP camera video inputs] [32 IP camera video inputs] [64 IP camera video inputs] with up to 12 MP resolution for each IP input.
3. The NVR shall use the Smart H.265+, H.265, Smart H.264+and H.264 Video compression protocols.
4. The NVR shall have a maximum bandwidth of [320] Mbps.
5. The NVR shall offer Automatic Network Replenishment (ANR) technology to ensure that data is not lost during a network outage.

2.2 16/32/64-CHANNEL 1.5U 16PoE 4K&H.265 NETWORK VIDEO RECORDER [DHI-NVR5416-16P-4KS2] [DHI-NVR5432-16P-4KS2] [DHI-NVR5464-16P-4KS2]

- A. General Characteristics:
 - 1. The NVR shall be an embedded processor with Embedded Linux operating system to record video from IP cameras.
 - 2. The NVR shall be capable of storing up to 24 TB of data from [16 IP camera video inputs] [32 IP camera video inputs] [64 IP camera video inputs] with up to 12 MP resolution for each IP input.
 - 3. The NVR shall use the Smart H.265+, H.265, Smart H.264+and H.264 Video compression protocols.
 - 4. The NVR shall have a maximum bandwidth of [320] Mbps.
 - 5. The NVR shall offer Automatic Network Replenishment (ANR) technology to ensure that data is not lost during a network outage.
 - 6. The NVR shall support IVS, Fisheye Dewarp, POS and ANPR.
 - 7. The NVR shall support Easy4ip to realize remote surveillance at anytime and anywhere.
 - 8. The NVR shall be powered by a built-in power supply and consume less than 14.5 W of power(without HDD).
 - 9. The NVR shall support IPC UPnP, 16PoE ports and supply max 150W.

- B. Display
 - 1. The NVR shall offer one (2) HDMI and one (1) VGA display interfaces.
 - 2. The NVR shall offer display resolutions of: 3840 x 2160, 1920 x 1080, 1280 x 1024, 1280 x 720, and 1024 x 768.
 - 3. The NVR shall offer [1/4/8/9/16][1/4/8/9/16/25/36] [1/4/8/9/16/25/36/64] multi-screen display.
 - 4. The NVR shall offer an on-screen display that lists the camera title, time, video loss indication, camera lock indication, motion detection, and recording indicator.

- C. Interface
 - 1. The NVR shall have [16][32][64] IP video channels
 - 2. The NVR shall offer one (1) USB 2.0 auxiliary port and two (2) USB 3.0 auxiliary port. .
 - 3. The NVR shall offer one (1) Audio In port and one (1) Audio Out port, with a two-way talk capability.
 - 4. The NVR shall offer sixteen (16) Alarm In port and six (6) Alarm Out port

- D. Storage
 - 1. The NVR shall come with four (4) SATA ports that can each support a 8 TB HDD.

- E. Playback and Backup
 - 1. The NVR shall allow recorded video searches by time/date, motion detection event, Exact Search, and Smart Search.
 - 2. The NVR shall offer the following playback functions: Play, Pause, Stop, Rewind, Fast Play, Slow Play, Next File, Previous File, Next Camera, Previous Camera, Full Screen, Repeat, Shuffle, Backup Selection, and Digital Zoom.
 - 3. The NVR shall allow data backup via a USB/eSATA device or another network.

- F. Recording
 - 1. The NVR shall employ the Smart H.265+, Smart H.264+, H.265 and H.264 video compression protocols.
 - 2. The NVR shall offer video recording resolutions of 12Mp, 8Mp, 6Mp, 5Mp, 4Mp, 3Mp, 1080p, 720p, D1, CIF.
 - 3. The NVR shall offer a record rate (bandwidth) of 320 Mbps.
 - 4. The NVR shall allow a bit rate between 16 Kbps to 20 Mbps per channel.

 - 5. The NVR shall offer the following built-in recording modes:
 - a. Manual
 - b. Schedule, regular or continuous
 - c. Motion Detection
 - d. Camera Blank
 - e. Video Loss
 - f. Stop
 - 6. The NVR shall offer a recording interval between 1 minute and 120 minutes. In addition, the NVR shall offer a pre-record interval of between 1 second to 30 seconds, and a post-record interval of between 10 seconds to 300 seconds.
 - 7. The NVR shall be capable of recording from third-party devices, including: Dahua, Arecont Vision, AXIS, Bosch, Brickcom, Canon, CP Plus, Dynacolor, Honeywell, Panasonic, Pelco, Samsung, Sanyo, Sony, Videotec, and Vivotek.

G. IP Connectivity

1. The NVR shall allow full control and configuration capabilities via a TCP/IP network.
2. The NVR shall offer one (1) RJ-45 port (10/100/1000 M).
3. The NVR shall offer 16 PoE ports
4. The NVR shall support a maximum of 128 user access points.
5. The NVR shall conform to the ONVIF 2.4.1 and to the CGI standard.
6. The NVR shall support the IPv6 internet-layer protocol for packet switched internetworking across multiple IP networks.
7. The NVR shall support the IPv4/ IPv6, HTTP, HTTPS, SSL, TCP/IP, UDP, UPnP, SNMP, RTSP, RTP, SMTP, NTP, DHCP, DNS, PPPOE, DDNS, FTP, IP Filter.
8. The NVR shall support the IOS and the Android mobile operating systems.
9. The NVR shall support unicast and multicast.

H. Installation Requirements

1. The NVR shall be capable of operating in temperatures between -10°C to +55°C (+14°F to +131°F), 86 to 106 kpa.
2. The NVR shall receive power from a built-in power source and consume less than 17.5 W of power(without HDD).

PART 3 – EXECUTION

3.1 EXAMINATION

- A. Examine areas to receive devices and notify adverse conditions affecting installation or subsequent operation.
- B. Do not begin installation until unacceptable conditions are corrected.

3.2 PREPARATION

- A. Protect devices from damage during construction.

3.3 INSTALLATION

- A. Install devices in accordance with manufacturer's instruction at locations indicated on the floor drawings plans.
- B. Perform installation with qualified service personnel.
- C. Install devices in accordance with the National Electrical Code or applicable local codes.
- D. Ensure selected location is secure and offers protection from accidental damage.
- E. Location must provide reasonable temperature and humidity conditions, free from sources of electrical and electromagnetic interference.

3.4 FIELD QUALITY CONTROL

- A. Test snugness of mounting screws of all installed equipment.
- B. Test proper operation of all video system devices.
- C. Determine and report all problems to the manufacturer's customer service department.

3.5 ADJUSTING

- A. Make proper adjustment to video system devices for correct operation in accordance with manufacturer's instructions.
- B. Make any adjustment of camera settings to comply with specific customer's need.

3.6 DEMONSTRATION

- A. Demonstrate at final inspection that video management system and devices functions properly.
