1. The NVR shall be an Intel processor with Embedded Linux operating system to record video from IP cameras.
2. The NVR shall be capable of storing up to 128 TB of data from [64 IP camera video inputs] [128 IP camera video inputs] with up to 12 MP resolution for each IP input.
3. The NVR shall use the H.265 and H.264 Video compression protocols.

2.2 64/128-CHANNEL 3U 4K&H.265 NETWORK VIDEO RECORDER [DHI-NVR616DR-64-4KS2] [DHI-NVR616DR-128-4KS2]

- A. General Characteristics:
 - 1. The NVR shall be an Intel processor with Embedded Linux operating system to record video from IP cameras.
 - 2. The NVR shall be capable of storing up to 128 TB of data from [64 IP camera video inputs] [128 IP camera video inputs] with up to 12 MP resolution for each IP input.
 - 3. The NVR shall use the H.265 and H.264 Video compression protocols.
 - 4. The NVR shall have a maximum bandwidth of [384] Mbps.
 - 5. The NVR shall offer Automatic Network Replenishment (ANR) technology to ensure that data is not lost during a network outage.
 - 6. The NVR shall support IVS, Fisheye Dewarp, POS and ANPR.

 - 6. The NVR shall have a 7-inch HD LCD screen on it (support 1080P display).
- C. Interface
 - 1. The NVR shall have [64] [128] IP video channels
 - 2. The NVR shall offer two (2) USB 2.0 auxiliary port, two (2) USB 3.0 auxiliary port and one (1) eSATA auxiliary port, one (1) miniSAS auxiliary port.
 - 3. The NVR shall offer one (1) Audio In port and one (1) Audio Out port, with a two-way talk capability.
 - 4. The NVR shall offer sixteen (16) Alarm In port and eight (8) Alarm Out port
- D. Storage
 - 1. The NVR shall come with sixteen (16) SATA ports that can each support an 8 TB HDD.
 - 2. The NVR shall support HDD hot-swap.
- E. Playback and Backup
 - 1. The NVR shall allow recorded video searches by time/date, motion detection event, Exact Search, and Smart Search.
 - 2. The NVR shall offer the following playback functions: Play, Pause, Stop, Rewind, Fast Play, Slow Play, Next File, Previous File, Next Camera, Previous Camera, Full Screen, Repeat, Shuffle, Backup Selection, and Digital Zoom.
 - 3. The NVR shall allow data backup via a USB device, eSATA device or another network.
- F. Recording
 - 1. The NVR shall employ the H.265 and H.264 video compression protocols.
 - 2. The NVR shall offer video recording resolutions of 12Mp, 8Mp, 6Mp, 5Mp, 4Mp, 3Mp, 1080p, 720p, D1, CIF.
 - 3. The NVR shall offer a record rate (bandwidth) of 384 Mbps.
 - 4. The NVR shall allow a bit rate between 16 Kbps to 20 Mbps per channel.
 - 5. The NVR shall offer the following built-in recording modes:
 - a. Manual
 - b. Schedule, regular or continuous
 - c. Motion Detection
 - d. Camera Blank
 - e. Video Loss
 - f. Stop
 - 6. The NVR shall offer a recording interval between 1 minute and 120 minutes. In addition, the NVR shall offer a pre-record interval of between 1 second to 30 seconds, and a post-record interval of between 10 seconds to 300 seconds.

7. The NVR shall be capable of recording from third-party devices, including: Dahua, Arecont Vision, AXIS, Bosch, Brickcom, Canon, CP Plus, Dynacolor, Honeywell, Panasonic, Pelco, Samsung, Sanyo, Sony, Videotec, and Vivotek.

G. IP Connectivity

1. The NVR shall allow full control and configuration capabilities via a TCP/IP network.
2. The NVR shall offer four (4) RJ-45 port (10/100/1000 M).
3. The NVR shall support network mode: single NIC, fault-tolerance, load balance.
4. The NVR shall support a maximum of 128 user access points.
5. The NVR shall conform to the ONVIF 2.4.1 and to the CGI standard.
6. The NVR shall support the IPv6 internet-layer protocol for packet switched internetworking across multiple IP networks.
7. The NVR shall support the IPv4/ IPv6, HTTP, HTTPS, SSL, TCP/IP, UDP, UPnP, SNMP, RTSP, RTP, SMTP, NTP, DHCP, DNS, PPPOE, DDNS, FTP, IP Filter.
8. The NVR shall support the IOS and the Android mobile operating systems.

H. Installation Requirements

1. The NVR shall be capable of operating in temperatures between -10°C to +55°C (+14°F to +131°F), 86 to 106 kpa.
2. The NVR shall receive power from two (2) AC100V-240V power source (redundant power supply and hot-swap) and consume less than 51 W of power (without HDD).

PART 3 – EXECUTION

3.1 EXAMINATION

- A. Examine areas to receive devices and notify adverse conditions affecting installation or subsequent operation.
- B. Do not begin installation until unacceptable conditions are corrected.

3.2 PREPARATION

- A. Protect devices from damage during construction.

3.3 INSTALLATION

- A. Install devices in accordance with manufacturer's instruction at locations indicated on the floor drawings plans.
- B. Perform installation with qualified service personnel.
- C. Install devices in accordance with the National Electrical Code or applicable local codes.
- D. Ensure selected location is secure and offers protection from accidental damage.
- E. Location must provide reasonable temperature and humidity conditions, free from sources of electrical and electromagnetic interference.

3.4 FIELD QUALITY CONTROL

- A. Test snugness of mounting screws of all installed equipment.
- B. Test proper operation of all video system devices.
- C. Determine and report all problems to the manufacturer's customer service department.

3.5 ADJUSTING

- A. Make proper adjustment to video system devices for correct operation in accordance with manufacturer's instructions.
- B. Make any adjustment of camera settings to comply with specific customer's need.

3.6 DEMONSTRATION

- A. Demonstrate at final inspection that video management system and devices functions properly.
